1. ELIGIBILITY

This show is open to artists who exhibit work of their own concept, design and execution, in all media. Each participant is responsible for insurance and sale of his or her work. **IMPORTED OR COMMERCIAL ITEMS WILL NOT BE CONSIDERED OR PERMITTED.** Misrepresentation at any level will be grounds for removal from the show and all future shows in Grand Lake presented by the Grand Lake Chamber of Commerce.

2. PHOTOS

Four photos or slides will be submitted with the application form labeled with your name. Alternatively you may list your website on the application page and we will review your images there. These will be used to determine approval of your application. They must represent your work fairly and accurately. Accepted applicants will have their photos/slides returned at the Festival. Those not accepted will have their photos/slides returned by mail.

3. SELECTION/NOTIFICATION

Entries will not be considered if they do not comply with the rules of this application. Entries will be considered solely on the merits of work pictured in the submitted photos/slides. Participation in previous year's Festivals does not ensure acceptance for 2008. Notification of acceptance will be made by August 30th, 2008.

4. FEES

Booth fee is \$175.00 per space. Make checks payable to the Grand Lake Area Chamber of Commerce, PO Box 429 Grand Lake, CO 80447. The fee includes a business license for the Town of Grand Lake and security. The booth fee is not refundable. If you are not accepted into the Festival, your booth fee will be returned with your photos/slides, provided you include a stamped self-addressed envelope. No commission is charged on your sales.

5. EXHIBIT SPACE

A 10' x 10' booth space is provided and will be assigned by the Grand Lake Fall Festival. Double space is available for purchase if required. No tables or chairs are included. **NO STAKES ARE TO BE USED TO SECURE TENTS.** Please provide bags of sand if necessary. **NO ELECTRICITY IS AVAILABLE.** The festival is held outdoors, suitable protection from the elements is encouraged. There will be no rain date.

6. SALES TAX

Town of Grand Lake (4%), Grand County (1%), State of Colorado (2.9%). The total tax to be collected and submitted to the Colorado Department of Revenue is 7.9%.

Setup may begin on Friday after 4:00p.m.

8. SECURITY

Security will be provided Saturday night from 6:00p.m. until 10:00a.m. Sunday morning. There will be no security on Friday night.

9. PUBLICITY AND PHOTOGRAPHS

Please enclose any information about yourself, your work or techniques that would be appropriate for publicity releases, or include your own public relations file.

The Grand Lake Area Chamber of Commerce may photograph or record any and/or all participants and booths. The Chamber will own these photographs or recordings. All entrants consent to the use of their name, photograph, likeness, voice and/or video for advertising and promotional purposes, including online announcements, worldwide and without additional compensation.

As a participant of the 2008 Grand Lake Fall Festival I fully agree to the following:

I recognize and acknowledge that I assume full risk of any injury, property damage, or loss which I may sustain as a result of my participation in any and all activities connected with or associated with my participation in the Festival. Further I understand that I display and store my products overnight at my own risk.
